

Motor for More Campaign (Policyholders)

ELIGIBILITY

- 1. The Campaign is applicable to the following insurance product(s) (which shall be referred to as "Insurance Plan"), which is underwritten by MSIG during the Campaign Period:
 - a) MSIG Private Car Comprehensive Insurance; and/or
 - b) MSIG Commercial Vehicle "A" Permit and "C" Permit Comprehensive Insurance
- 2. Applicable to both new and renewal policies purchased during the Campaign Period, excluding Third Party, Third Party Fire & Theft, and Standalone Commercial Vehicle Trailer Policy.
- 3. The purchase of the Insurance Plan can be made directly via MSIG or through any of MSIG's authorized insurance advisors.
- 4. Cancellation or Endorsement(s) performed or transacted during the Campaign Period will not be eligible for the Campaign.
