This Product Disclosure Sheet (PDS) is designed to provide you with some key information on your Home SafeGuard Insurance.

Other customers have read this PDS and found it helpful; you should read it too.

1. What is Home SafeGuard Insurance?

Home SafeGuard Insurance is a comprehensive home policy that covers the private dwelling building and/or contents against fire and other named perils. Building sum insured is on agreed value basis when you use Building Cost Calculator (BCC) or property valuation report.

2. Know Your Coverage

As an illustration, for RM688.00 (before Service Tax and Stamp Duty) annually, you will receive the following coverage based on sum insured of RM500,000 on building and RM100,000 on contents for a landed house constructed of brick walls and tiled roof.

3. Know Your Obligations

For Home SafeGuard Insurance, you must pay the below premium:

The price you pay will be based on the sum insured, type of building and construction materials used, and elected additional coverage.

[^]Stamp duty payment for annual premium not exceeding RM150 is exempted until 31/12/2028. However, RM10 stamp duty shall be payable starting from 1/1/2029.

4. Other Key Terms

- Duty of Disclosure - You must provide complete and accurate information in the application/proposal form and disclose any matter that you know or could be expected to know to be relevant.
- You must ensure that your property is insured at the appropriate amount taking into account the renovation made to your property. If the amount insured in your insurance policy is less than the rebuilding cost (i.e. under-insurance), you are deemed to be self-insuring the difference. The average condition will apply in the event of a claim.
- The basis of compensation for loss/damage to the property:
 1. Agreed Value (on building only) - it will pay the sum insured as stated in the schedule which is agreed by you and us at the inception of the policy, if the cost of rebuilding exceeds 75% of the sum insured in the event of a loss. Cost of rebuilding is determined by BCC at <https://bcc.piam.org.my/> or a registered valuer and is valid for two years. The building coverage will automatically change to market value if you fail to provide a new valuation every two years.
 2. Market Value - it will pay the value of the property insured at the time of damage or loss less due allowance for wear and tear and/or depreciation and subject to the deduction of any excess and amount which you required to bear under the policy.
- Excess, being an amount you have to bear before you are paid. This is applicable for certain perils.
- All claims must be notified to us as soon as possible but not later than seven (7) days.

The list is **non-exhaustive**. You should refer to the policy wording for the full list of terms and conditions.

5. Can I cancel my policy?

Yes. You may cancel your policy at any time by giving a written notice to us. Upon cancellation, you are entitled to a refund of premium being adjusted on the basis of us retaining the customary short-term premium or minimum premium RM60.
