Sample Scenario

Eddie uses his car mainly to and from office with occasional family trips to nearby shopping centres. He estimates that his mileage limit should be less than 5,000km per year.

In August, Eddie received a notification from MSIG EZ-Mile App that he should top-up his mileage as he is close to 5,000km. If he exceeds his mileage limit without a top-up, his coverage will reduce to Third Party, Fire and Theft*. He decided to top-up as soon as he can and continues to enjoy comprehensive cover for the rest of the policy period. He calculates that he can still save on his premium even after 2nd top-up.

Jika dia melebihi had perbatuannya tanpa tambah nilai, perlindungan akan berkurang kepada perlindungan Pihak Ketiga, Kebakaran dan Kecurian*. Dia mengambil keputusan untuk menambah nilai secepat mungkin dan terus menikmati perlindungan komprehensif untuk sepanjang tempoh polisi. Menurut kiraannya, dia masih boleh menjimatkan premiumnya walaupun selepas tambah nilai kedua.
